Preliminary Applications

1. **RP 071-05** - A request by David L. Schlesinger to replat Tract A, Lance Lots Subd into two tracts of approximately 5.3 acres and 12.3 acres within the N½ NE¼ NW¼ , Sec 11, T1N R2W, FM AK (located at the corner of Jones Rd and Waldheim Dr).

2. **RP 066-05** - A request by the City of Fairbanks to combine Lots 1 thru 20, Block 22, Bjerremark Subdivision into one tract of 2.66 acres within Sec 15, T1S R1W, FM AK (bounded by 25th and 26th Ave, Bjerremark St, and Rickert St).
