# FAIRBANKS NORTH STAR BOROUGH ABSENTEE BALLOT APPLICATION

## GENERAL INFORMATION

1. Municipal elections are held annually the first Tuesday in October to elect approximately one-third of the FNSB Assembly, and School Board; and City Councils for the City of Fairbanks and City of North Pole; two at-large seats of the Interior Alaska Natural Gas Utility Board (IGU) are elected every year, except for every third year in which three board members are appointed by the Mayors of the Borough and Cities of Fairbanks and North Pole. The Municipal Mayors are elected every three years. For efficiency and public convenience during regular municipal elections, the Borough Clerk's Office processes all absentee ballot requests for all three municipalities. Run-off elections and special elections are held as needed or when called by the Assembly or Councils. In the event of a run-off or special election, each municipality is responsible for conducting that election.
2. You may apply for an absentee ballot(s) for any or all elections conducted by the Borough within the calendar year as long as the ballots for each election are sent to the same address. Note: Primary, general, and federal elections are conducted by the State of Alaska. To vote absentee in those elections, apply directly to the Alaska Division of Elections, Absentee Voting Office, 519 E. Ship Creek Ave., Suite 329, Anchorage, Alaska 99501-1677.
3. If you are in the Fairbanks North Star Borough, City of Fairbanks or City of North Pole within 15 days before the election, you may vote ABSENTEE IN PERSON. You do not have to complete this application to vote absentee in person.

## INSTRUCTIONS – ALL APPLICATIONS

- Absentee Voting:
  - By Mail - Your application must be received at least 7 days prior to the election. APPLY EARLY to be sure you receive your ballot(s) in time.
  - By Electronic Transmission – Your application must be received by 12:00 p.m. (Noon) Alaska Standard Time not less than the day immediately preceding the election. Note: Absentee voters requesting ballots by email requires the voter to print both the ballot and voter's oath and affidavit.
- Complete ALL information requested. Omissions may result in your application being rejected.
- **You MUST provide your residence address in the Fairbanks North Star Borough.** Use the description of physical location – street number, apt. #, etc.
- NOTICE TO ACTIVE DUTY MILITARY PERSONNEL: To remain registered in Alaska you must be an Alaska resident and provide your physical residence address within the State. If you have been assigned to an active duty station outside Alaska, you may wish to maintain your Alaskan residence address as it appears on your current registration record. If you provide a new residence address, it must be within the Fairbanks North Star Borough.
- SIGN your application. A friend, spouse or parent may not sign for you.
