BOROUGH ASSEMBLY

(All offices serve at-large)

Seat B – 3-year term

Seat I – 3-year term

Incumbent: Matt Cooper

Assembly Qualifications. Candidates must:

- Be a qualified voter of the state of Alaska at a residence within the borough.
- Have resided within the borough for a period of one year preceding filing for office.
- A person shall not occupy or be a candidate for more than one elective seat at a time.
- Meet requirements as set forth in FNSBC Title 5.

Elections for these positions are conducted at large by all qualified voters of the borough.

Terms: The term of the office for borough assembly is three years or until a successor is elected and qualified. Service is to begin on the first Monday following certification of the election.

A person who has served two full successive terms as assemblymember may not be reelected to that elective office or body until one full year has intervened.

SCHOOL BOARD

(All offices serve at-large)

Seat C – 3-year term

Incumbent: Sharon McConnell

Seat D – 3-year term

Incumbent: Allyson Lambert

School Board Qualifications. Candidates must:

- Be a qualified voter of the state of Alaska, and a municipal voter (30 days before the election) in the school district
- A person shall not occupy or be a candidate for more than one elective seat at a time
- Meet requirements as set forth in FNSBC Title 5.

Elections for these positions are conducted at large by all the qualified voters of the borough.

Terms: The term of the office is three years and until a successor takes office as set forth in AS. 14.12.050.

REQUIRED WHEN FILING FOR ELECTED OFFICE

- Completed Declaration of Candidacy under oath
- Completed Public Office Financial Disclosure statement that complies with state law (AS 39.50). Filers must file their POFD forms electronically via MyAlaska (<https://myalaska.state.ak.us/apoc/form/>), then print a copy to file with the clerk. - \$25 non-refundable Filing Fee
- A Municipal Exemption Statement or Candidate Registration within 7 days of filing for candidacy
