FAIRBANKS NORTH STAR BOROUGH ABSENTEE BALLOT APPLICATION

GENERAL INFORMATION

1. Municipal elections are held annually the first Tuesday in October, to elect approximately one-third of the Assembly and School Board. The Mayor is elected every three years. Special elections are held when called by the Assembly.
2. You may apply for absentee ballot(s) for any or all elections conducted by the Borough within the calendar year as long as the ballots for each election will be sent to you at the same address. (Primary and General Elections are conducted by the State of Alaska. To vote by mail in those elections, apply directly to the Alaska Division of Elections, Absentee Voting Section, PO Box 110017, Juneau, Alaska 99811-0017.)
3. If you will be in the Fairbanks North Star Borough within 15 days before the election, you may prefer to vote ABSENTEE IN PERSON. Check with the Borough Clerk's Office for more information at (907) 459-1401.

INSTRUCTIONS – ALL APPLICATIONS

- Absentee Voting – By Mail. Your application must be received at least 7 days prior to the election. **APPLY EARLY** to be sure you receive your ballot(s) in time.
- Absentee Voting – Electronic Transmission. **Your application must be received not less than the day immediately preceding the election. A voter may transmit the ballot electronically no later than the day before the election.**
- Complete ALL information requested. It is required by law. Omissions will result in your application being rejected.
- You **MUST** provide your residence address in the Fairbanks North Star Borough. Use the description of physical location – street number, apt. #, etc. **(If you give a residence address in another state or county, or use a PO Box Number instead of a physical address, your application will be rejected.)**
- **NOTICE TO ACTIVE DUTY MILITARY PERSONNEL:** To remain registered in Alaska you must be an Alaska resident and provide your physical residence address within the State. If you have been assigned to an active duty station outside Alaska, you may wish to maintain your Alaskan residence address as it appears on your current registration record. If you provide a new residence address, it must be within the Fairbanks North Star Borough.
- **SIGN** your application. A friend, spouse or parent may not sign for you.
