The Fairbanks North Star Borough Assembly approved the special event fee in the 2015/16 Budget as follows.

Special Event Fee

This new fee will help offset the costs associated with set-up and clean-up of the facilities. During large events it is expected that the facility be left in the same condition as it was when reserved.

Terms and Conditions:

- For booked events with 200 or more people in attendance the fee is \$1.00 per person. This is in addition to the facility reservation fee. For example; a reservation fee under four(4) hours is \$30.00. There are 300 in attendance, the total rental would be 100 attendees that are not included in the reservation fee total cost \$130.00
- 1-200 is included in pavilion reservation
- 201 or more is \$1.00 per attendee
- No refunds will be issued
- This fee can be negotiated up to 75% off in exchange for services such as; user renting port-o-potties, providing extra garbage cans and then for clean-up leaving the facility in the same condition prior to rental.

no refunds will be issued for change in attendance numbers, however full refunds will be issued in the event of a cancellation with 48 hours notice.
