Ms. Smart summarized the report including the list of all businesses and the amount that each received per program. **Commissioner Hickok** asked if the list was divided by industry sectors. **Ms. Smart** said she had not, but it was being done state-wide by John Bitner.

Commissioner Hickok asked questions about the amount of funding received and the diversification of the funding. Ms. Smart explained the differences and fielded further questions from Commissioner Hickok regarding the government's role in ARDOR. Commissioner Hickok questioned whether the regional conference was still going on.

6. Explore Fairbanks – The Recent Cruise Ban and Other Issues Facing the Travel Industry

Ms. Smart introduced the piece and Commissioner Hickok stated it was an early document that was produced for Explore Fairbank's e-news.

Commissioner Hickok also iterated that land tours are reported to still be happening and travel restrictions have been lifted. Commissioner Hickok stated that PVSA (Passenger Vessel Services Act of 1886) was cost prohibitive as it features a fine charged per person. Ms. Smart asked about whether ships manufactured in the United States of America were subject to the same rules. Commissioner Hickok stated all but three cruise ships she was aware of were foreign flagged and manufactured somewhere other than the US.

Mayor Ward gave a summary of the Interior Alaska COVID-19 Impact and Recovery Plan. Ms. Smart discussed each category including Completed, In Progress, and No Action Taken. These were explained in depth. Mayor Ward also commented throughout. Commissioner Meeks stated he would like the administration to attempt to revise the plan with more targeted tasks to specific industries rather than the Commission attempting to do it. Commissioner Hickok stated the pandemic was not over and that land tours would require very stringent protocols to keep guests safe.

Ms. Smart gave an update on the current progress of the CEDS (Comprehensive Economic Development Strategy) project. Ms. Smart also stated that the Economic Development Commission will be the steering committee for the plan.
